

## LEGAL TERMS OF USE

PLEASE READ THIS DOCUMENT ENTITLED LEGAL TERMS OF USE CAREFULLY BEFORE USING THE AYITI NOW CORP ("ANC") WEB SITE OR OTHERWISE ACCESSING OR DOWNLOADING ANY INFORMATION FROM THIS WEB SITE (THE "SITE").

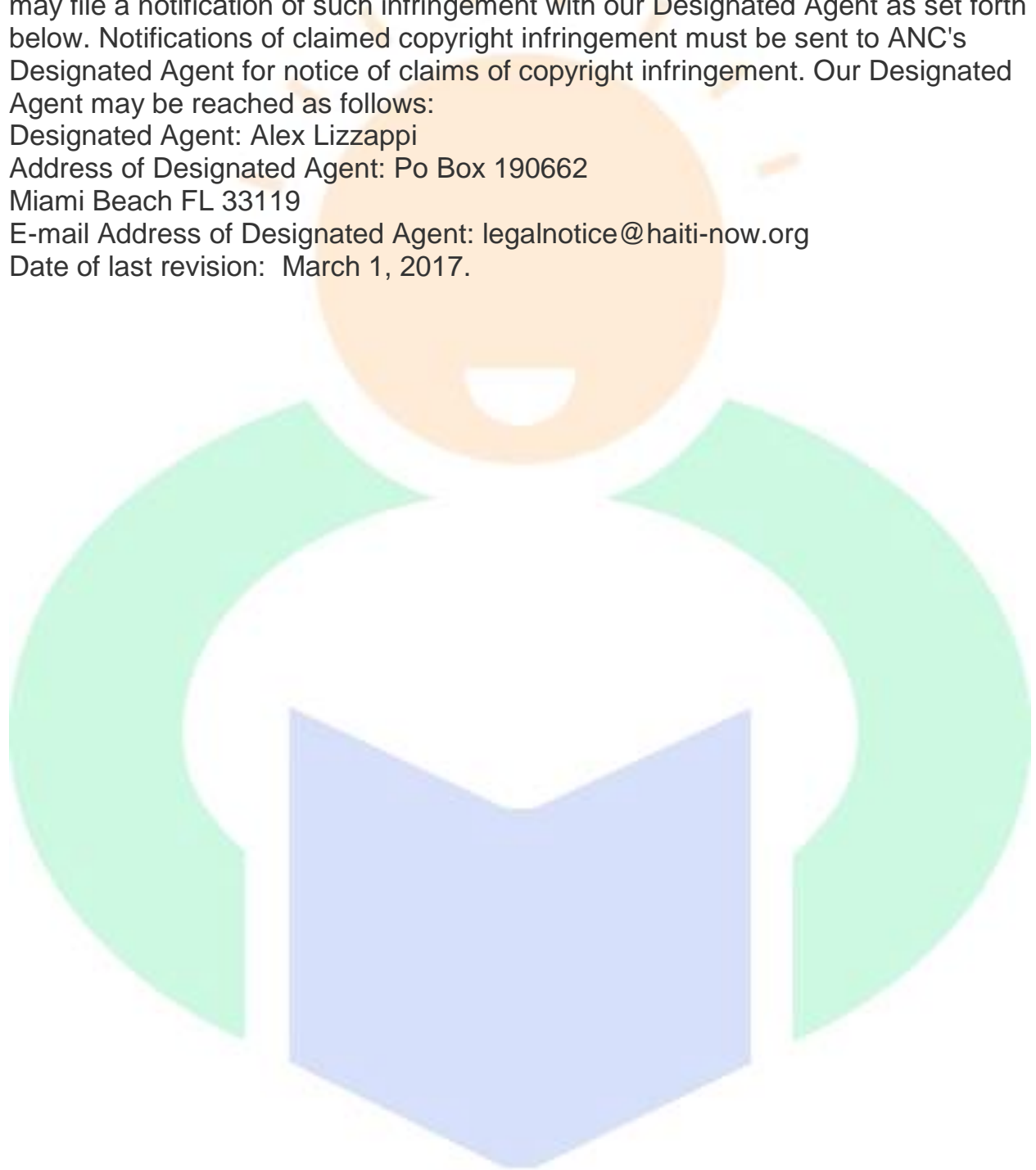
